- Notice of dental insurance increase for August still in negotiation with Delta Dental looks like it will be a \$5.00 increase but trying to get it below that point.
- The Managerial employees are asking for additional perks. They feel as if they are being solely treated as union employees which they are. I do not oppose what they are requesting:

Upon hire start with 7.5 hours of vacation monthly rather than .833 days per calendar month. This equates to 12 days' vacation year one rather than 9.996

Accrue three personal days per calendar year instead of two

• I would like to propose to the Union the following wage scale for nurses LPN \$16.50 = \$32,175; ADN \$21.00 = \$40,950; BSN \$22.50 = \$43.875; MSN \$24.00 = \$46,800. If approved by the board, I can present to the Union for ratification and need justification letter.
