F.R.E.S.H FARMER'S MARKET

The F.R.E.S.H. FARMER'S MARKET (FFM) is open seasonally from June through October but due to the COVID-19 Pandemic the FFM had limited services for the 2022-2023 season. Produce for the market was supplemented by the DeMange, Breaudigaum, and Keller farms. The FFM accepts EBT - LINK, Credit, Debit, Cash, WIC & Senior Summer Food Vouchers. The purpose of the FMNP is to provide fresh fruits, vegetables and herbs from farmer's markets to women, children and seniors at nutritional risk. Expand awareness and use of farmers markets through increased sales during the summer season. FMNP provides free coupons to eligible WIC Program Participants — Pregnant, Postpartum, Breastfeeding women and children 1-5 years of age. Eligible seniors who are 60+ years old and who have household incomes of not more than 185% of the federal poverty income guidelines.
